**Question 3:**

The JNAPC welcomes the recognition in Part One of the UK Marine Strategy that 'There is increasing awareness of the importance of our underwater cultural heritage and the historic environment which has significant social/cultural value' (UKMS Part One, section 2.5.6). We also welcome the statement that 'Plans are in place to consider whether social and cultural indicators and targets could be developed, and this will include a consideration of marine cultural heritage and the historic environment' (ibid.). This amounts to a recognition that additional monitoring programmes are required in respect of the social, cultural and heritage characteristics of the UK Marine Area and we look forward to their inclusion in monitoring the UK Marine Strategy as soon as possible. In the Government's response to this consultation, we would welcome an update on the plans said to be in place for social, cultural and heritage indicators and targets, and their monitoring.

#### 9 4) Are you aware of any additional marine monitoring currently being carried out that we have not covered which could contribute to our assessments and make them more effective?

**Question 4:**

All four authorities responsible for heritage in UK waters (Historic England; Historic Environment Scotland; Cadw; and the Department of Agriculture, Environment and Rural Affairs in Northern Ireland) monitor the extent, condition and benefits of cultural heritage in the UK Marine Area. The scope and format of heritage asset monitoring data differ in each home country. Nonetheless, monitoring data on heritage assets is available from these authorities and efforts should be made to incorporate it within the monitoring programme of the UK Marine Strategy.

Provision should be made to ensure that data from all four authorities responsible for cultural heritage in UK waters is addressed comprehensively within the UK Marine Monitoring and Assessment Strategy (UKMMAS) through, for example, the Productive Seas Evidence Group; and marine heritage should be represented on the Marine Assessment and Reporting Group (MARG). Incorporating marine heritage data within the monitoring programme of the UK Marine Strategy would help to demonstrate the benefits to communities that arise from the human dimension of UK seas, past and present.
